



Returning Women Students Scholarships Common Application Instructions

The goal of the Returning Women Students Scholarships is to support undergraduate students aged 25 and older in the completion of a first bachelor's degree so they can advance their careers after graduation. In additional to financial support through three different scholarships, the Returning Women Students Scholarships Program also offers a peer mentor program and various other support services and resources. Before completing this application for the 2014-2015 academic year, please make sure to review the scholarship criteria that are common for all three scholarships. Please also be mindful of the specific criteria required for each individual scholarship and include the additional information as necessary. The boxes below can also serve as a checklist for you prior to submitting your application packet.

		This is a signature program for the Women's Center's Returning Women Students Scholarship Program and each year a cohort of approximately 10-12 Newcombe scholars are selected. Eligible scholars are selected based on three overall components: (1) financial need, (2) other extenuating life situations that create additional need, and (3) clarity of educational and career goals.

- □ Please provide your most-up-to-date college transcript. It may be official or unofficial. If you are a recent transfer to UMBC, please also include a transcript from your former institution.
- □ Please provide a brief statement that addresses why you chose to return to school, what you are studying and your goals related to your education, and your intended career goal(s) after graduation. (700 words maximum)
- □ Please identify any barriers or challenges that you have faced or are facing in pursuing your degree and describe how admission into the Returning Women Students Scholarship Program will help you in overcoming these barriers or challenges. (350 words maximum)

You may include item 2 and item 3 in one essay if preferred

□ (OPTIONAL ATTACHMENT) If you are applying to the Newcombe or AEGON scholarships and are experiencing unusual personal or family hardship that would not be highlighted in your FAFSA application or has not otherwise been documented through this application process, please also include that information in your application packet. Be prepared to provide documentation to support your statement (e.g. medical bills, child care expenses, etc.) if requested by the scholarship committee. (250 words maximum)

Scholars Program Requirement for All Scholarships Awardees:

- 1. If you are selected as a scholarship recipient, you will be required to sign the Women's Center Scholarship Agreement Form and any other additional forms required by the Office of Financial Aid and Scholarship before receiving the award.
- 2. Recipients will be required to write a thank you letter to the scholarship foundation describing how this award will impact their educational and career goals. Additional details will be included in the award letter. Failure to honor this requirement may result in forfeiture of the award.
- 3. Students must agree to comply with the program requirements outlined in the Women's Center Scholarship Agreement Form. These requirements include:
 - a. Meeting one-on-one with a professional staff member at the Women's Center at least once a semester
 - b. Participating in the Returning Women Scholars Mentoring Program. Program requirements include:
 - i. Attending a 2-hour orientation prior to the fall semester and one other Returning Women Forum event throughout the fall semester; two other meetings will be required in the spring semester.
 - ii. Meeting with your mentoring peer at least once a month
